6.1 PROJECT LAUNCHED !!

Meditech Implementation Underway!!

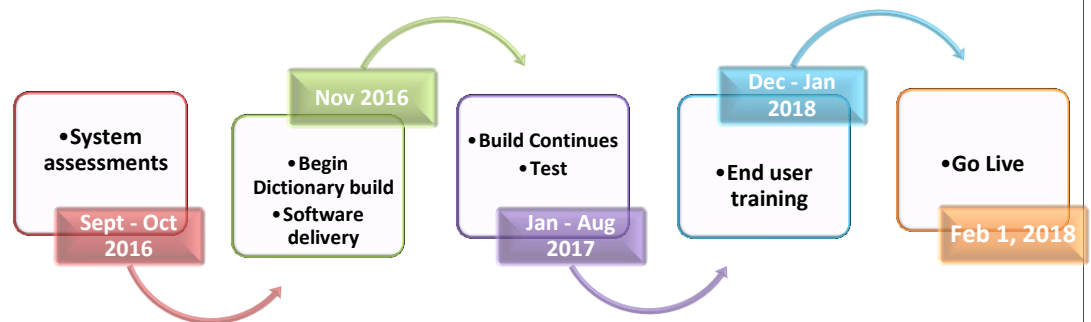
Scheduled for a February 1, 2018 go-live, the 6.1 kickoff event launched a 17 month implementation project. The project consists of 16 teams involving 79 SVMC staff members working on this effort to replace the current Meditech system. Additionally, consultants from Navin Haffty & Associates are guiding the implementation using WebEx demonstrations, onsite classroom training sessions, conference calls, internal status meetings, subject matter experts and onsite meetings.

Physicians are also actively involved with the implementation, many serving on the Physician Informatics Committee, which is responsible to review and approve much of the newly provided standard content. This content includes evidence based order sets and documentation templates for physicians, and care plans and documentation content for the clinical areas.

All applications will GO-Live on the same day, **Feb 1, 2018** ! For most historical information, you will have an EMR to EMR link and your patient information will be accessible.

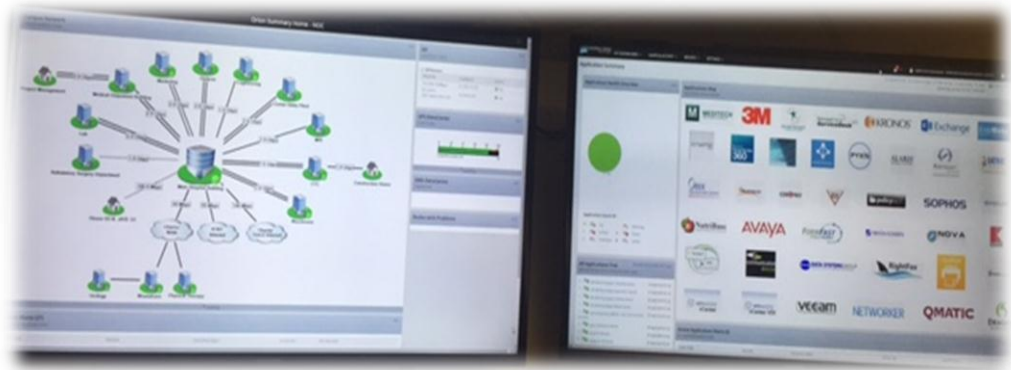

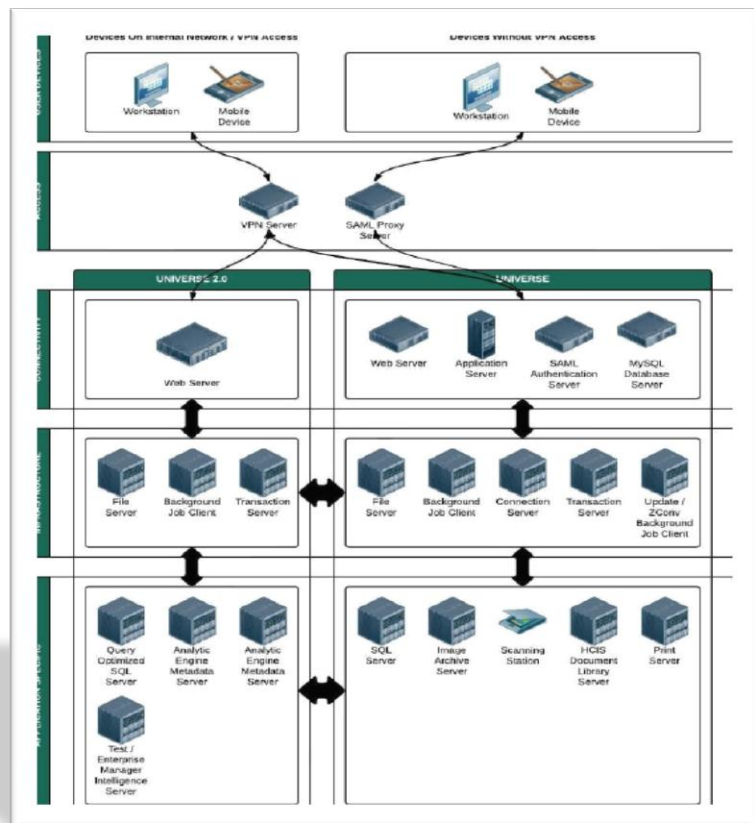


Team Spotlight – MIS & TECH

2017 is already flying by and this month Team Spotlight is MIS and TECH. Part of MIS is the creation of User access. One of most positive improvements is the combination of Person and Provider user access menus. With both menu combined as one, all information can be filled out once instead of toggling back and forth between different menus. It is hard to believe as small as IT department is, we continue to store all the data and equipment onsite. With only a staff of 15, all systems are monitored 24/7, broadcast on two TVs and alerts instantly when there is a problem.

Application Spotlight

Web Ambulatory

A great addition to this implementation will be a fully integrated web-based Ambulatory application that can work for both MD Offices as well as hospital outpatient departments. This means one single patient record – which includes one med list, one problem list, one MAR, and one appointment scheduling system.

It's truly Web-based, It's browser-agnostic. It's written with all standardized tools, so it can run on an iPad or an Android device or a Surface tablet. It's got all the conventions that physicians expect to use in every other part of their lives, and Meditech brought all of that capacity to the electronic health records so they can order, they can document, they can review, they can e-prescribe, they can discharge all through browser-based access to a fully Web-based tool. So they're tapping and swiping in this environment. They're no longer clicking and scrolling and onerously pecking their way through medical records. Everything has been completely rewritten for the physician experience, from ordering to documenting to reviewing to e-prescribing. Physicians will be able to write orders on their patients from their office and have them waiting for their patients to check in to the hospital. For example, Pre-op orders can be waiting and initiated as soon as possible.

Transformational population health management is available from within the Ambulatory module. The Ambulatory Registry tool allows you to manage the wellness of a specific population and measure effectiveness. Integrated into workflows, Ambulatory Registries allow you to identify at-risk patients, and access their charts to document or place orders. Engaging with at risk patient populations has never been easier.

We are currently designing this application for the new PRIME Clinic, and will be available to any interested Physicians for use in their practice. Please contact Traci Follett for more information about enrolling your practice with SVMC's Ambulatory solution.
